Chair's Message

Kathleen Becan-McBride, Ed.D., MT(ASCP)^{CM}



It is with pleasure and excitement that I introduce myself as the incoming Chair of the ASCP BOR Board of Governors. I am honored to have the opportunity of working with our Past-Chair, Cindy Johns, MSA, MT(ASCP)^{CM}SH^{CM},

who has been a wonderful leader, and our stalwart Executive Director, Dr. Blair Holladay, SCT(ASCP)^{CM} as well as all of the members of the Board of Governors, the BOR Staff and our BOR Volunteers. Even in the critical economic environment facing our nation, we can be optimistic about the future of the ASCP Board of Registry. The BOR continues to hold the "Gold Standard of Excellence." In fact, at the Fall ASCP Meeting, the 80th year celebration of the ASCP BOR exemplified the continued standard of excellence in certification nationally and now internationally. With our national and global focus, at the Fall 2008 meeting, the BOR Board of Governors adopted the following new Mission Statement – "Provide Excellence in Certification of Laboratory Professionals on Behalf of Patients Worldwide." It is the intent of

the BOR to protect the health and safety of the public through quality standardized testing and certification. In accordance with the new Mission Statement, the BOR has expanded its global program from five countries to 28 – offering certification services in countries seeking to strengthen clinical laboratory services and laboratory professional values. As of December 2, 2008, the total number of international applicants for all international categories (international MT, MLT, MP, PBT) was 1394.

We are anticipating even more exciting news in the progress between the National Credentialing Agency (NCA) and the ASCP BOR to unite into a single certification agency. Our agencies are continuing to work towards this unification goal that will be of great importance to our profession and our future laboratory professionals.

Another highlight that supports additional enthusiasm for now and the future of the BOR is the strong performance that is occurring with the BOR's Certification Maintenance Program (CMP). The rate of participation in the program is above that originally projected with an overall 45% participation in the program and

Update from the October 2008 Board of Governors' Meeting

The Board of Governors of the Board of Registry met on October 18 and 19 in Baltimore, MD. The following actions were taken at this meeting:

- A new mission statement was adopted by the ASCP Board of Registry: "Provide excellence in certification of laboratory professionals on behalf of patients worldwide."
- The Qualification in Laboratory Compliance will be discontinued effective September 1, 2009. The last date to submit an application form for this qualification is June 1, 2009.
- A special exception has been granted for active U.S. military personnel enrolled in Military Laboratory Specialist courses and NAACLS/CAAHEP accredited laboratory training programs to permit them to take the certification examination prior to graduation from the program. Active U.S. military personnel who are enrolled in Military Laboratory Specialist courses have been approved to sit for the ASCP Medical Laboratory Technician examination within the last three weeks of Phase II training provided they are in good standing. Active U.S. military personnel enrolled in NAACLS/CAAHEP accredited Histology, Cytotechnology, Specialist in Blood Banking or Medical Technologist training programs will also be permitted to sit for the appropriate examination within the last three weeks of the training program if they are in good standing. The Board granted this special exception since active military personnel are deployed immediately following graduation. A final transcript will be required before examination results and a certificate are mailed. - The Board of Governors of the Board of Registry approved the following eligibility requirements for international certification in microbiology, Technologist in Microbiology, M(ASCP[®]):

Route 1: MT(ASCP[®]) certification AND a baccalaureate degree or equivalent from an accredited/approved* educational institution; OR

Route 2: Baccalaureate degree or equivalent in any biological or chemical science from an accredited/approved* educational institution, AND one year full time acceptable clinical laboratory experience in Microbiology in an accredited/approved** laboratory facility; OR

Route 3: Baccalaureate degree or equivalent in any biological or chemical science from an accredited/approved* educational institution, AND successful completion of a structured program in Microbiology*. The structured program in Microbiol-

ogy must be equivalent to the curriculum for Microbiology in the Medical Technology Program; OR

Route 4: Graduate level degree (Master's, Doctorate, or equivalent) in Microbiology or an appropriately related field from an accredited/approved* educational institution, AND six months full time acceptable clinical laboratory experience in Microbiology in an accredited/approved** laboratory facility. These six months of experience must be under the supervision of the Laboratory Director.

*Accredited/approved by a governing regulatory association or Ministry. Countries without a prevalent system of accreditation/approval must have programs/educational institutions approved by an International Advisory Board appointed by the ASCP Board of Registry, or eligibility will be determined by transcript evaluation. Training programs which do not grant university credit as part of a Medical Laboratory program will be counted as experience.

**Accredited by JCI, CAP, ISO 9000 or a governing regulatory association or Ministry. Countries without a prevalent system of accreditation must have laboratories approved by an International Advisory Board appointed by the ASCP Board of Registry.

- The revalidation requirements for the Qualification in Immunohistochemistry (QIHC) have been revised to expand the types of activities acceptable to maintain this Qualification. The IHC qualification may be revalidated by documentation of 30 contact hours of acceptable continuing education in Immunohistochemistry, as defined on the list of topic areas, OR by completion of 15 contact hours of acceptable continuing education as described above and 15 contact hours of other activities related to immunohistochemistry as follows:
 - Employer offered courses (e.g. in-service, vendor sponsored)
 - College/university coursework (10 contact hours for each quarter hour; 15 contact hours for each semester hour)
 - Research & preparation for presenting a workshop or course (first time only; 5 contact hours)
 - Authoring journal articles for peer-reviewed publications (5 contact hours)
 - Authoring a book (over 300 pages – 21 contact hours; less than 300 pages – 14 contact hours; chapter – 7 contact hours)
 - Editing a book (5 contact hours)
 - Presenting posters/exhibits (3 contact hours)
 - Serving on an examination committee (2 contact hours per year)
 - Serving on committees/boards related to IHC (national, state, regional, local – 2 contact hours per year)

ASCP Exams Soon Available to Service Members On-Base

Starting in mid-December, U.S. Military Service members and their family members will be able to take ASCP certification exams at over 100 DANTES and on-base National Test Centers (NTCs) worldwide. DANTES and NTC test sites are located on military bases and provide Service members with the education support they need for career enhancement while on active duty. ASCP exams will be delivered along with several other medical exams currently delivered at DANTES locations. The ASCP Board of Registry is excited to work with DANTES and Pearson VUE (ASCP-BOR's computer-based testing provider) to offer convenient, on-base testing to Service members and their families.

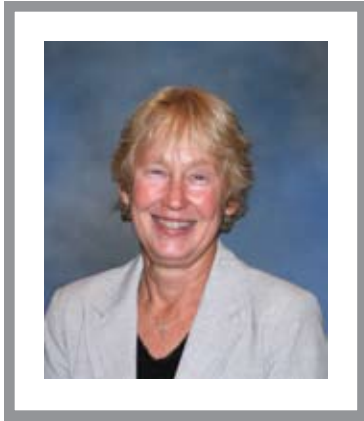

The following elected officials took office beginning October 2008. The members of the executive committee of the BOR BOG are as follows:

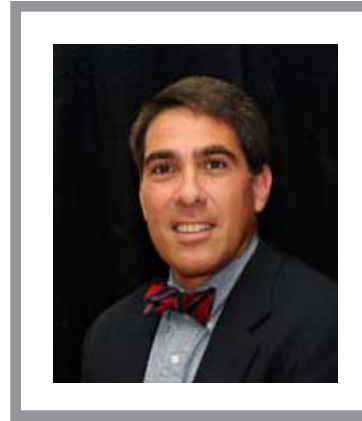
Kathleen Becan-McBride, EdD, MT(ASCP)^{CM}

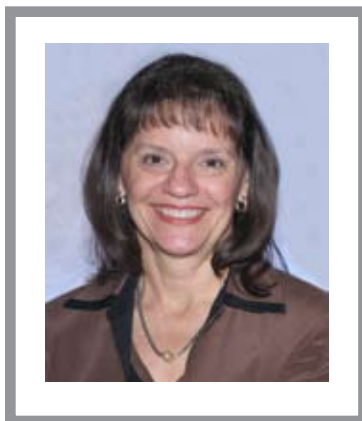
Walter Oliveira, MT(ASCP)^{CM}SI

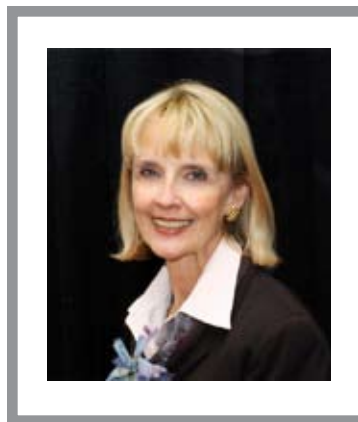
Kenneth Emancipator, MD, FASCP

Beware of Fraudulent Certification

The number of people misrepresenting their certification status has significantly increased over the years. There is an individual in Georgia who falsely claimed ASCP certification as a Medical Technologist (MT) at five different places of employment within the last three years. Another individual in Illinois claimed MT certification in applying for employment in three different states, two within less than one month. Both of these individuals submitted forged documents, ASCP ID cards or Certificates of Qualifications, to potential employers. They were identified as fraudulent because the employers verified their certification through the Board of Registry online verification service.

Misrepresentation can occur in a variety of ways. Individuals have improperly obtained ASCP Member ID cards or certificates of qualification from ASCP certified individuals, made copies and changed the name to their own. This copy is then used to obtain employment in a higher level job. In some cases, individuals have modified their own ASCP Member ID card to indicate a higher level of certification.

When you are hiring laboratory professionals, do not accept copies of certificates. Ask to see the original. ASCP Member ID cards should not be used to verify certification. If they

are not able to produce an original certificate, certification should be verified through online verification of certification. The individual's certification category, certification number and date of certification will be provided by e-mail or fax. Verification of certification has become even more important with time-limited certificates. With the introduction of the Certification Maintenance Program (CMP) beginning in 2004, recently certified individuals must complete this program every three years. Individuals who do not successfully complete the program may no longer use the certification initials after their name [e.g. MT(ASCP)^{CM}] and their certification is no longer valid. Any inquiries regarding their certification status will indicate that the individual is no longer ASCP certified.

Protect the integrity of your own ASCP credentials and your certification record by not loaning your certificate or ASCP Member ID card to another individual. Individuals who misrepresent or misuse their certification status will be barred from future certification in any category and any current certification may be revoked. To maintain the value of ASCP certification and, most importantly, for patient safety and welfare, we must all be vigilant in recognizing and reporting fraudulent credentials.

International Certification ASCP-BOR International Certification Expands to 28 Countries



Agency decentralizes services to offer improved global customer service and patient safety

CHICAGO – Sept. 10, 2008 – The American Society for Clinical Pathology Board of Registry (BOR) has expanded its global program from five countries to 28 – offering certification, lifelong education, network opportunities and other services in countries seeking to strengthen clinical laboratories. The international certification exam became reality in South Korea and the Philippines in 2006. Hong Kong, Panama and Guyana were added in 2007.

Global certification effectively offers laboratory professionals around the world the opportunity to earn the gold standard in certification from ASCP-BOR and to reap the career benefits of this distinction. Currently, ASCPⁱ certification is available in the categories of International Medical Technologist, International Medical Laboratory Technician, International Technologist in Molecular Pathology and International Phlebotomy Technician.

International Technologist examinations in Chemistry and Microbiology are in development.

In April, the BOR Globalization Committee met in Panama to discuss a draft decentralization plan. The plan would help to evenly disseminate international certification responsibilities among the Chicago office, country-specific advisory boards, and regional representatives.

“International certification was designed to meet the global demand for a reliable health care system that will preserve patient safety and standardize and ensure excellence in laboratory practice worldwide. BOR volunteers and staff feel a true sense of accomplishment because we are beginning to see the results of the hard work that went into globally implementing this extraordinary certification,” says Kathleen Becan-McBride, EdD, MT(ASCP)^{CM}, immediate past chair of the ASCP-BOR Globalization Committee.

The strategy for next year includes satellite offices in Panama and the Philippines. The goal is to eventually set up regional satellite offices on each continent. These offices will provide improved customer service by allowing regional representatives to explain the ASCPⁱ application

process in the native language to prospective applicants. Furthermore, they will provide additional support to program directors, laboratory officials, practitioners, and students throughout the region.

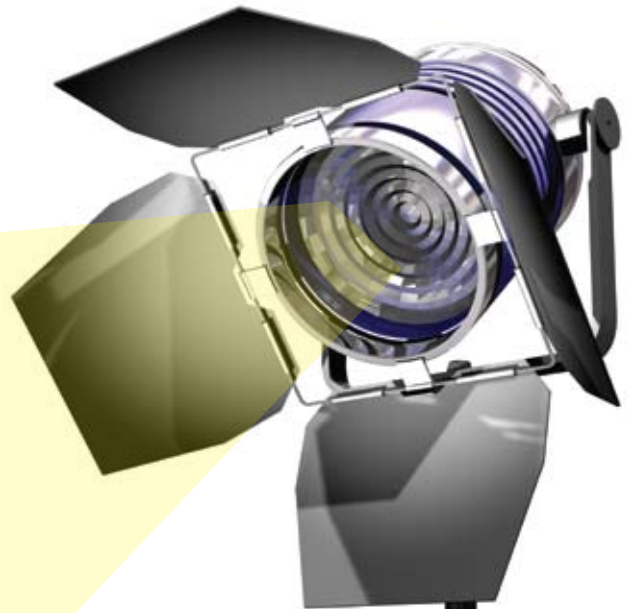
