# Uganda Cancer Institute Partners with ASCP to Provide Telepathology Services

## **Country Updates**

- Rwanda—The deployment team for ASCP has completed planning for the Rwanda Military Hospital (RMH) telepathology deployment—to serve RMH, Kigali Central Teaching Hospital (CHUK), and King Faisel Hospital—and equipment is being shipped to the site. The deployment team will visit in May to set up the equipment and begin scanning the first cases for diagnostic assistance before the end of May. The RMH will be the first site for deployment of radiation therapy in Rwanda, which is scheduled to go live in 2018.
- Uganda—The Uganda Cancer Institute (UCI) is planning implementation for telepathology with ASCP in Kampala, Uganda—to serve UCI, Mulago Hospital, and Makere University with a goal of August 2017 for deployment to coincide with the 50th anniversary of UCI. UCI was recently named an <a href="East African Center of Excellence">East African Center of Excellence</a> funded by the Africa Development Bank. The Central Public Health Laboratories, soon to be the Uganda National Health Laboratory Service, recently instituted a 100-hub system in Uganda, which connects all patients to vital laboratory services, including histopathology through coordination with

Kampala pathology laboratories. By adding telepathology, Uganda will be very close to 100 percent access for all patients to rapid, accurate diagnostics and cancer care through the UCI network.

 In March, ASCP Chief Medical Officer Dan A. Milner, Jr., MD, MSc (Epi), FASCP, also visited Kenya, Tanzania, and Congo, to meet with partners and to conduct country assessments.

#### **Partners**

After a visit to the Butaro Laboratory in Rwanda, the staff of
the National Public Health Laboratory of Kenya and the
Ministry of Health have plans for securing automated
histology equipment to install in its lab in Nairobi which will
serve as a central hub for biopsies from across the country.
They also plan to include whole slide imaging with
connectivity to ASCP pathologists for support. This project is
funded by the Kenyan government.



## Meetings

- Dr. Milner was an invited guest at the recent WeCan Symposium in Kigali, Rwanda, which brought patient advocate groups to discuss challenges, solutions, and planning around care and treatment for patients in East Africa. Dr. Milner discussed pathology and the importance of an accurate diagnosis with the advocates. Several advocate volunteers will work with ASCP to help promote the "patient perspective" for each county in which ASCP plans to work. The symposium was led by Dr. Julie Gralow, of the University of Washington, who serves as a co-chair of the ASCP Care and Treatment Committee for the Africa project.
- Dr. Milner attended the National Institutes of Health National
  Cancer Institute's Center for Global Health's CUGH premeeting in Bethesda, Md., along with Dr. Larry Shulman
  (Care and Treatment Committee, Dr. John Flanigan (Care and Treatment); Dr. Julie Gralow (Care and Treatment); Dr. Anne Rositch (Monitoring and Evaluation), Dr. Quentin Eichbaum (Medical Education) and Dr. Rick Marlink
  (Bioethics). Drs. Shulman, Gralow, Rositch, and Eichbaum all made presentations, and the subject was cancer in Lowerand Middle-Income Countries (LMICs).
